GCDA Annual Membership Cost \$50 for Adults; \$40 for Juniors Current Negative Coggins MUST accompany entry. OFFICE FEE: \$25, HAUL-IN/WALK-IN FEE: \$25 if not Stabling, NON-COMPETE/SCHOOLING HORSE \$35. All riders/ owners/ handlers must restrict horse use to GCDA leased arenas, warm ups and barn areas as designated ONLY.

2. AWARDS - Ribbons for six places. Trophy for first place. ALL ties will be broken.

3. STABLING or WALK-IN - Permanent stalls with doors, \$35 per stall (Stalls available from Ship-In Saturday 12 noon through Sunday at the end of the competition). **PLUS A SEPARATE STALL CLEANING DEPOSIT CHECK FOR \$25** (The \$25 check will NOT be deposited if stall is left clean per Jim Brandon rules). **Initial bedding**

SAFETY HELMETS ARE RECOMMENDED AT ALL TIMES WHEN MOUNTED** and are the responsibility of the rider. Organizers assume NO LIABILITY for Rider/Owner and his/her horse or personal property.
