- ENTRIES (class fees are per class)** - Sunday CLASS FEES: \$35- Introductory Thru Grand Prix, and USDF Musical Freestyles for GCDA Members. **MUST BE A CURRENT GCDA MEMBER TO SHOW.** GCDA Annual Membership Cost \$50 for Adults; \$40 for Juniors. . Current Negative Coggins MUST accompany entry. OFFICE FEE: \$25, HAUL-IN/WALK-IN FEE: \$20 if not stabling. All riders/ owners/ handlers must restrict horse use to GCDA leased arenas, warm ups and barn areas as designated ONLY.  
Non Competing horse (schooling) per horse \$25; Returned Check \$50 + Bank Fee. Management reserves the right to split, cancel, or change the day of classes to balance unusual amounts of entries. **All riders/ owners/ handlers must restrict horse use to GCDA leased arenas, warm-ups and barn areas as designated ONLY. Sorry, we do not accept credit cards. NO REFUNDS FOR ANY REASON AFTER THE CLOSING DATE, including USEF art. Times will be posted the day before the show after 1:00 p.m. at the show grounds and mailed to your winter address about 1 week before the show & also available on GCDA website. Times are tentative. Consult posted times each day on grounds.

5. **STABLING & WALK-IN** - Permanent stalls with doors, wood with metal frame construction, 10 X10, \$35 per stall (Ship-In night through Show day at the end of the competition). ) **PLUS A SEPARATE STALL CLEANING DEPOSIT CHECK FOR \$25** (The \$25 check will NOT be deposited if stall is left clean per Jim Brandon rules). Initial bedding not provided, but may be pre-purchased for \$7.00 per bag. **ABSOLUTELY NO HORSES will be accepted for stabling OR schooling until 11am , the day before the competition begins-early arrivals will be subject to a \$50 penalty per horse—Move in /schooling hours are from 12noon- 5:30pm.** Haul-in/Walk-in fee is \$35 per day if not stabling.

Located at the **Palm Beach County Equestrian Center at 7500 Forest Hill Blvd, West Palm Beach, FL.** From the Florida Turnpike, Exit #93, Lake Worth Blvd., go west to HWY 441/SR 7, turn right/head north to Forest Hill Blvd; turn right /east, go approximately 1 ½ mile & turn right into Equestrian Park Entrance. Follow posted signs for show office and barns. From the North—Okeechobee exit on Florida Turnpike #99, go west/right to HWY 441, turn left/south; go 3 miles to Forest Hill Blvd, turn left/east, go approximately 1½ mile & turn right into Equestrian Park Entrance. Follow posted signs for show office and barns.

The undersigned, for and on behalf of myself, my heirs, personal representatives, successors and assigns, hereby releases and forever discharges Gold Coast Dressage Association, Inc or "GCDA", Jim Brandon Equestrian Center("Property"), of Palm Beach, FL, their agents, officers, employees, volunteers, successors and assigns of and from any and all claims or demands of any nature whatsoever which I may have or hereafter acquire or have accrued to them arising as a result of, or incident to, my presence on or utilization of said "Property" or any of its facilities. SAFETY HELMETS ARE RECOMMENDED AT ALL TIMES WHEN MOUNTED** and are the responsibility of the rider. Organizers assume NO LIABILITY for Rider/Owner and his/her horse or personal property.
